Extreme Limousine Contract Agreement

Cancellation Policy:

- Deposits are refundable if cancellation occurs within 48 hours of initial booking. Any cancellations that occur after the 24 hour period will be charged 50% of the agreed booking amount up until the the day of the scheduled service. Cancellations made on the same day as the scheduled service will be charged 100% of the booking amount along with the 15% gratuity.

Terms & Conditions:

1. No alcohol consumed by anyone less than 21 years of age. This act will not be tolerated and services will end immediately.
2. No smoking inside the vehicle, \$100.00 charge per incident. No exceptions.
3. Clean-up fee for vomit in the vehicle will be assessed, \$100.00 per incident.
4. No food allowed in bus including Jello shots without prior written approval. \$100.00 per incident.
5. All unruly persons will be dropped off at the sole discretion of the driver & no refunds.
6. We will not be responsible for any lost, damaged, or stolen property. No exceptions.
7. All entertainment including CDs and DVDs is to be provided by the client.
8. Driver is not responsible for illegal acts during rental.
9. The contractual party is responsible for guests and assumes full responsibility for any damages to the vehicle caused by client or guests whether by accident, neglect, or intent.
10. While the bus is in motion, guests must be seated for their safety. Extreme Limousine will not be responsible or liable for any injuries incurred during any unsafe practices.
11. Driver may terminate services at any time without refund if the driver deems the party unruly or endangering the safe operation of the vehicle.
12. Do not stand or dance on seats. Please keep feet on floor at all times.
13. Do not open any exits or windows unless an emergency exit is necessary.
